# JNITED WAY IMPACT COUNCIL VOLUNTEERS

## **Understanding the Process**

The Community Investment Committee is comprised of volunteers representing a cross section of the community from the parishes of Allen, Beauregard, Calcasieu, Cameron and Jefferson Davis. The Committee assists in deciding the most effective way to distribute United Way of Southwest Louisiana campaign funds. It is the committee's responsibility to ensure that each donor's campaign contributions are invested in closely-monitored, local programs that truly benefit the needs of the Southwest Louisiana community.

The volunteers from the committee are divided into groups; each is based on one of the four United Way of Southwest Louisiana impact areas - Education, Financial Stability, Health and Basic Needs. These groups are referred to as Impact Councils. Each Council includes a Chair, Co-Chair and United Way staff member. Each Council will visit their assigned agencies to evaluate their program's effectiveness. During the on-site visit, agencies will give a presentation explaining their programs, services and investment of United Way funds. Council members are encouraged to ask questions regarding the agency and their programs.

### **Duties Include:**

- Attend orientation meeting, usually 1/2, day in January (Finance Committee) or March (Program
  Committee) to get acquainted with other volunteers and staff who are participating in the community
  investment process including those who will be reviewing the same programs. Volunteers will receive
  necessary program and budget information on each assigned program, including links to the online
  application software.
- Review and learn about the requesting agency, its clients, mission and program in detail, including budget information.
- Attend and participate in an agency site visit, for each program assigned. Each visit should last 1-2 hours and will be scheduled within a 1-3 day period, depending on individual schedules. Volunteers are encouraged to understand the agency's governing boards, policies, budget and program information.
- Evaluate each program online utilizing United Way's ecimpact program.
- Attend the recommendation meeting in May(usually 1/2 day) where each program will be presented by the reviewing Impact Council to the entire Community Investment Committee for consideration of funding. A recommendation from the United Way Board of Directors will be the result of the meeting.
- Keep materials, findings and matters discussed confidential.

Time Requirements: Approximately 20-30 hours from January - June for Finance Committee members or March - June for Program Committee members including training, travel, council meetings and agency visits.

Conflict of Interest: Persons associated with an agency receiving or seeking United Way funding should disclose this to United Way staff. No person may serve on the Community Investment Committee if they or a member of their immediate family are employed by or is currently serving on the Board of Directors of any agency that is currently receiving or seeking a grant from United Way of SWLA.
