



This Waiver of Liability (the "Waiver") executed by the "Volunteer" in favor of the Louisiana Food & Wine Festival, The AdFish Group, LLC, the City of Lake Charles, Visit Lake Charles, Rouses Market, SOWELA, Bayou Rum Distillery, Coffee:30/Southlake Theater and including all its festival sponsors, exhibitors and all their directors, officers, employees, staff and agents (collectively and as may be referred to herein, "The Festival").

I, the Volunteer, desire to work as a non-compensated volunteer for the Louisiana Food & Wine Festival and engage in the activities related to being a volunteer for an event.

I hereby freely and voluntarily, without duress, execute this Waiver under the following terms:

1. **Waiver and Release.** I, the Volunteer, release and forever discharge and hold harmless, The Festival and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my volunteer work at the event. I understand and acknowledge that this Waiver discharges The Festival from any liability or claim that I, the Volunteer, may have against The Festival with respect to bodily injury, personal injury, illness, death, or property damage that may result from my participation at the event. I also understand that The Festival does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance, in the event of injury, illness, death or property damage.
2. **Insurance.** I, the Volunteer, understand that I expressly waive any such claim for compensation or liability on the part of The Festival, beyond what may be offered freely by the representative of The Festival in the event of such injury or medical expense.
3. **Medical Treatment.** I hereby release and forever discharge The Festival from any claim whatsoever which arises or may hereafter arise on account of first-aid treatment or other medical services rendered in connection with an emergency during my time with The Festival.
4. **Assumption of the Risk.** I understand that my time with The Festival may include activities that may be hazardous to me. I hereby expressly and specifically assume the risk of injury or harm in these activities and release The Festival from all liability for injury, illness, death, or property damage resulting from the activities of my time with the Festival.
5. **Photographic Release.** I grant and convey unto The Festival all right, title, and interest in any and all photographic images and video or audio recordings made by The Festival during my work for The Festival including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.
6. **Other.** I expressly agree that this Waiver is intended to be as broad and inclusive as permitted by the laws of the State of Louisiana in the United States of America, and that this Waiver shall be governed by and interpreted in accordance with the laws of the State of Louisiana. I agree that if any clause or provision of this Waiver shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
